DIRECT DEBIT AUTHORISATION

**Dear Parents** 

Effective August 2011, direct debit is mandatory in paying school fees for all students attending ESF Schools / PIS. Enclosed please find a Direct Debit Authorization form and instructions on how to fill in the form. Please note that your child's school place is only secured if all fees are paid in full.

Fees are due on the first day of each month from September to June each school year, and ESF will direct debit your bank account on the second working day of each month. In order to avoid bank charges, please ensure there is sufficient fund in your bank account every month.

Please follow the instructions attached to fill in this direct debit form and write down your child's name, school attending at the top of the form. Please leave the child account number blank if your child is new to the College or transferred from an ESF school.

The completed direct debit form should be sent together with the admission package back to your child's school. You will receive a confirmation from us once the direct debit authorization is set up successfully with the bank.
